Mr. Samuel Vanlalhriata Chhangte, learned Standing Counsel for the NHIDCL submits that the entire stretch of road from Kawnpui to Aizawl via Khamrang has been taken over by the NHIDCL on 07.06.2025. He however does not know when the work for repairing the road would be completed. He also submits that M/s. J Infratech Limited has been given the contract work for repairing the said road.

On considering the submission made by Mr. Samuel Vanlalhriata Chhangte, learned Standing Counsel for the NHIDCL, M/s. J Infratech Limited, J-House, B-103, South City-1, Near Signature Tower, Sector-30, Gurugram-122001, Haryana, Email: infojcipl@gmail.com/tender@jinfratech.com is impleaded as respondent No. 12. Registry to make a new Cause Title accordingly.

Issue notice to the respondent No. 12 through the NHIDCL.

Steps to be taken by the petitioner for service of notice upon the respondent No. 12 through speed post.

The NHIDCL shall also inform M/s. J Infratech Limited that they have been impleaded as a party and they should appear on the next date. An affidavit should be submitted by the respondent No. 7 in this regard by 31.10.2025. The respondent No. 7 shall also positively file an affidavit by the next date stating as to when the work on the Kawnpui-Sairang road would be completed and the status of the work as on today.

It is made clear that if no affidavit, as directed by this Court, is filed by 31.10.2025, the respondent No. 7 shall personally appear before this Court on 06.11.2025.

List the matter again on 06.11.2025.
